# NHS COVID-19 contact-tracing app

An App has been designed and built by the NHS to help slow the spread of the coronavirus. It will send users an alert if they have been in close contact with other users of the app who've reported that they're experiencing coronavirus symptoms and allows the user to self-isolate as a result. The app is voluntary and does not collect any personal data. #### **Nest update**

Nest users need to make sure that they can still access the email associated with their Nest account as Nest says it will be notifying users before it rolls out mandatory two-factor authentication starting this month (the authentication will be a six-digit code sent to users over email). The changes were announced earlier this year in response to reports that Nest's security cameras were being "hacked".
